Affordable Warmth Dividend is the £100 payment made by the council to Glasgow residents who are over 80 to help with the additional expenses of keeping warm during winter.

To apply, please complete the form overleaf and return to me with documentation that confirms your date of birth and your residency in Glasgow, such as photocopies of birth certificate and utility bills. You should not send passports or bank books in the mail. If you receive housing benefit or council tax benefit then you do not need to provide supporting documentation.
